Saturday

HIGH to LOW (24C", 24", 20", 16", 12", 8", 4")

Sunday

LOW to HIGH (4", 8", 12", 16", 20", 24", 24C")

CLASS ORDER

BOTH Days: Briefing at 8:10 am – first run at 8:30 am

SAT EX/MAS FAST – OPN/NOV FAST - EX/MAS JWW– EX/MAS STD - OPN JWW - OPN STD - NOV JWW - NOV STD

SUN T2B – EX/MAS JWW– EX/MAS STD - OPN JWW - OPN STD - NOV JWW - NOV STD

WALKTHRUS

For EX/MAS STD and EX/MAS JWW on BOTH Days

4" – 16" Walk1 – Walk 2 – Run **20" – 26"** Walk – Run

FAST Classes: EX/MAS → WALK/RUN

OPN / NOV FAST Walk together

Run OPN FAST → Run NOV FAST (no separate walkthrough)

Walkthru Groups will be clearly marked on the Gate Boards

All other classes will have one walk

CHECK-IN and MEASURING

WE ARE SCHEDULED TO HAVE 2 VMOs at this trial. All dogs needing to be measured must be measured PRIOR to running by a VMO, Measurements will take place before each class. Please allow sufficient time before your dog's run to be measured.

We will not be using Armband labels at these trials. However, you will need to know your Armband number in order to do an At Trial move-up. Please bring a printed or an electronic copy of your trial confirmation so you will have your armband number with you.

MOVE-UPS

Move-ups must be received by the Trial Secretary in writing (E-mail preferred) prior to 6pm on Monday, October 22, 2018.

Be sure that I have acknowledged receipt of your move-up. Please preface all correspondence with "BACV" in the Subject line.

ADDITIONAL SITE INFORMATION

- **No Smoking on Trial Grounds** - All smoking must be done in individual cars in the designated smoking parking area or self-contained RVs. Please dispose of cigarette butts.
- Please do not attach any tenting or crating to the fencing.
- Always pick up any trash or waste material and dispose of in trash bins.
- Spectators are welcome but please leave your dogs at home!
- Park only in designated areas as indicated by signs and attendants.
- RVs staying overnight must have reservation on file, payment submitted and will be parked in designated area
- **Little Creek Reservoir Park** is immediately across the street from the site with nice walking paths (~ 2 miles wooded along the reservoir), well-maintained public restrooms, dog-friendly (on leash).

SMOKING PARKING POLICY

There will be a Special Designated Parking section for Smokers wishing to smoke in their cars at the site. As you drive in the double gates to the parking field, proceed straight to the back fence and look for the red, white & blue flags and signs designating the parking area for Smokers. This does not apply to the Judge or Trial Chairman who have designated parking near the Large Barn.

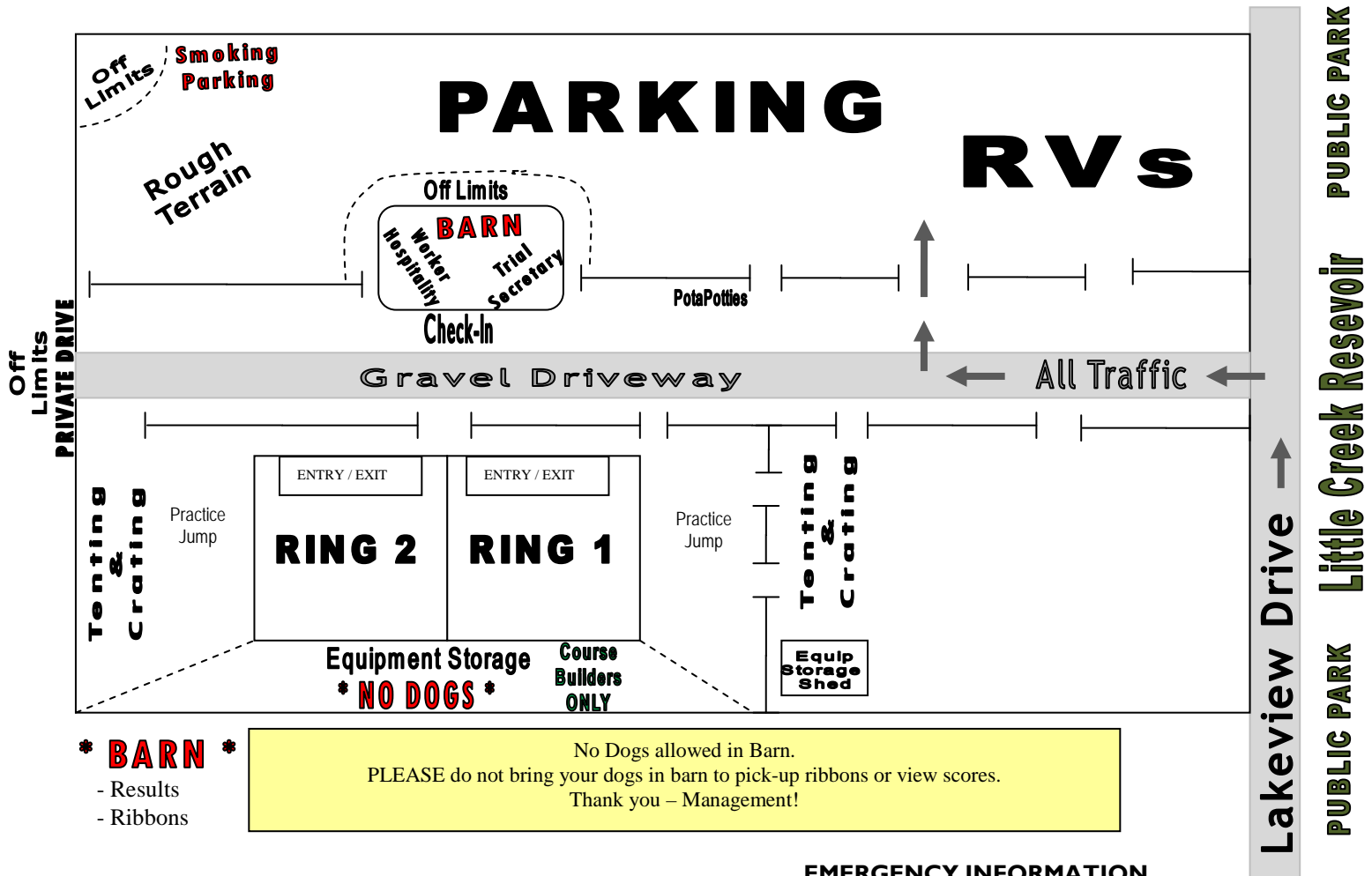

From the South via Rt I-64 West

- I-64 West toward Richmond, Take EXIT 231A (Norge/Toano)
- Turn **RIGHT** at the end of the ramp onto SR 607 (Croaker Rd).
- Go 1.5 miles to light - turn **RIGHT** on Rt 60 West (Richmond Rd)
- Go 1.8 miles and turn **LEFT** onto SR 610 (Forge Rd)
- Go 2.2 miles and turn **LEFT** onto Lakeview Dr
- Go ~ 1/8 mile to **WHITE FENCING**, gravel drive on **LEFT**

From North via I-64 East (from Northern VA & Richmond Areas)

- I-64 East to Williamsburg/Norfolk/Hampton
- Take EXIT 227 (Toano/Williamsburg)
- Turn **RIGHT** at the end of the ramp onto SR 30 Old Stage Hwy
- Go straight ~ 3 miles (**Road changes names to Richmond Rd/Rt 60**)
- Turn **RIGHT** onto SR 610 (Forge Rd)
- Go 2.2 miles - Turn **LEFT** onto Lakeview Drive
- Go ~ 1/8 miles to **WHITE FENCING**/gravel driveway on **LEFT**
