****NOTE:** Building will be locked 1 hour after the last run each day.

Wed Afternoon – 2pm Early Set Up Open to All Willing to help with event set up. Helpers may come in, lay their tarps down to reserve that "prime" spot and then come help with the ring/equipment set up. Vouchers will be provided for set up helpers.

Thursday – General set-up/crating will be available starting on Thursday morning

The center will open at 7am all days.

RUNNING ORDER & SCHEDULE

EX/MAS STD and EX/MAS JWW walkthroughs will be split as follows:

- 4" - 8" Walk – Run
- 12" Walk – Run
- 16" Walk – Run
- 20" Walk – Run
- 24" - 24C" Walk – Run

NOTE: Open & Novice FAST will walk together but run separately.

Novice & Open FAST WALK Together →

Run All **Open** → Run All **Novice**

EX/MAS FAST will walk-run by itself.

All other classes will have one walkthrough.

Judges may further split walks at their discretion.

**** Open and Novice JWW classes take precedence over EX/MAS STD class.**

Judge's briefings will only be at the beginning of each class – NOT before each jump height.

If you think you will miss your scheduled walkthru due to a conflict, walk with an EARLIER jump height!

For those with conflicts, you are asked to please walk the courses with an EARLIER height group if the conflict would mean you can't walk with your height class. You can also run at the end of the earlier height group or at the beginning of your height group instead of at the end. All conflicts must be approved by the judge.
 We realize that handlers with multiple dogs will have some conflicts.
 Please be sure to mark and/or notify the Gate stewards in **BOTH RINGS** that you have a possible conflict.

EARLY CHECK-IN and MEASURING

Early Check-In for Gate sheets will be located in **BLUE BINDERS** across from each ring. Check-In begins at 7:15am on all days. We are scheduled to have three Volunteer Measuring Officials (VMOs) on Thursday through Sunday. All dogs needing to be measured must be measured **PRIOR** to running. Measurements will take place before each class. Remember that our VMO is a volunteer and running her dogs in the trial. Please allow sufficient time before your run for your dog to be measured. If the VMO is not available you will need to be measured by the judge of record prior to your 1st run.

TRIAL SITE

These trials will be held in a large indoor fan-cooled arena on dirt. There is plenty of room for crating indoors, and lots of grassy area to walk dogs. A concession stand will be open during trial hours, and there are a number of restaurants and fast food establishments nearby. Clemson restaurants and lodging establishments are roughly 4 miles to the west; Anderson restaurants and lodgings are roughly 8 miles to the east.

GENERAL

- Please be considerate of other exhibitors. Do not let your dog urinate inside the arena, on garbage cans, equipment etc., someone has to handle these!
- Flexi-Leads **MUST** be kept at the **2' LOCKED** position when used **IN** and **NEAR** the building.

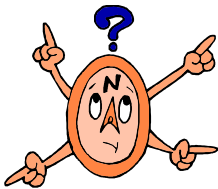

DIRECTIONS TO THE TRIAL SITE



From the South: Take I-85 exit 14 and go left on Hwy 187 North. Proceed 5.9 miles. Turn left on Hwy 76/28 West. Go 2.1 miles and turn **LEFT** on Queen Street. The T. Ed Garrison Arena will be on your left in .5 miles. Enter at Arena Parking sign.

Note: Follow signs to the arena when you turn onto Queen Street. Your GPS will guide you **WRONG!**

From the North: Take I-85 exit 19B (Hwy 76/28 West) and go 7.7 miles. Turn **LEFT** on Queen Street; facility will be on your left in .5 miles. Enter at Arena Parking sign.

From Clemson: From Hwy 123, take Hwy 76/28 East and go 3.3 miles. Turn **RIGHT** on Queen Street. Arena is on your left in .5 miles. Enter at Arena Parking sign.

Day to Day move ups must be submitted in person to the trial secretary no later than 15 minutes after the last run is judged for each class (FAST, STD & JWW).

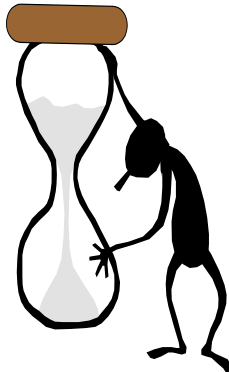
