Classes with more than 1 walk will have **No 5 min to 1st dog**.

CHECK-IN and MEASURING

We are scheduled to have three VMOs at this trial. Please allow yourself sufficient time to be measured before your 1st run. Measurements will take place when the VMOs are available. We will not be using Armband labels at these trials. However, you will need to know your Armband number in order to do an At Trial move-up. Please bring a printed or an electronic copy of your trial confirmation so you will have your armband number with you.

SITE INFORMATION & RULES

- The show site is climate controlled indoors on turf flooring.
- Do not park in front of any gate or doorway.
- Respect the traffic cones when parking – they are marking the turning radius for truck traffic. Our neighbors may use cones to block more areas than indicated on this map – please respect them!
- Do not park in the Southern Air lot (directly across Barricade Ln from LUDS) on FRIDAY. We are allowed to park there only on SAT/SUN.
- **Parking in the alleyway on the Exit door side is for Trial Officials only.** Anyone parking in this area without permission will be asked to move.
- NO RV Parking Onsite – No Day OR Night Parking
- Dogs must be kept on leash when not in the ring.
- Do not potty your dogs on the neighboring tenants' lawns.

If you are caught, you will be asked to leave for the weekend and forfeit your runs.

- **Crating:** Priority will be given to club members and volunteers. If there is additional space, it will first come first served. Crates are allowed only on the tarps provided. Please make sure your chairs have caps that will not dig into the flooring. Please conserve space. Please fold personal chairs when not in use and do not block aisles. If possible, remove your crates when you are done running/volunteering so exhibitors later in the day have somewhere to crate. The trial committee may consolidate set-ups in the crating area in order to fit more volunteers. If you are only entered on Friday and Sunday, please consider removing your set-up so exhibitors can use the space on Saturday.
- All turf accidents must be reported immediately and \$5 clean up fee paid.

May CVSSC Trial Updated COVID19 Procedures and Trial Info

CVSSC (Central Virginia Shetland Sheepdog Club) & LUDS (Level Up Dog Sports), have put in place the following procedures for our agility trial at LUDS for the safety of our exhibitors and adherence to government, state, and CDC ordinances and guidelines.

MASK REQUIREMENT

Masks are optional.

We will be using the Agility Gate app for an electronic gate.

Exhibitors are responsible for arriving on time for their walk-thrus and runs.

- If you plan on crating from your vehicle, please park so your exhaust does not go into another vehicle.
- **One way entry/exit** as follows: Enter the building on the parking lot side and exit on the other side where the street goes between the buildings.
- We will be lining up the next five dog & handler teams to run. Please respect each teams space in the queue. Exhibitors are responsible for arriving on time for their walk-thrus and runs. The practice jump is inside on the turf.
- **Volunteers.** Worker sign-up link will be posted to the GoneDoggin' Agility website. Workers will earn a \$2 voucher per class worked along with a light lunch, snacks, and drinks.
- **Gate sheets** - check-in using the Agility Gate app. This allows exhibitors to check in for their runs through the app and to follow along by looking at the gate sheets as dogs are crossed off when they run. To use the Agility Gate app, please download it from the Apple App Store or the Google Play Store. There is a display TV with the running order by the entrance door. There will also be a preliminary running order on our website prior to the trial.
- **Course maps** will be posted on the Agility Gate app the day of the trial and on Alex's website: <https://loakespark.wordpress.com/>. Course maps will also be posted on the wall outside the ring, but please do not congregate around them. There will not be paper course maps.
- As per AKC guidelines... "Exhibitors may choose to place leashes in their pockets or wear them (around waist, crossbody, etc.) during their runs. If the dog grabs the leash the run will be scored as an "E". If the leash falls out of the handler's pocket, or off of their body, there is no call unless the dog grabs the leash".

MOVE-UPS

Move-ups must be received by the Trial Secretary in writing (E-mail preferred) prior to 6pm on Monday, May 22, 2023. Be sure that I have acknowledged receipt of your move-up. Please preface all correspondence with "CVSSC-May" in the Subject line. Make sure you know your armband number in order to do an At-Trial move-up. At-trial move-ups must be turned into the trial secretary no later than 15 minutes after the final class. The At-trial move-up binder will be by the ribbon table.

EMAILS ARE NOT ACCEPTED FOR AT-TRIAL MOVE-UPS.

You MUST fill out at a move-up at the trial to do an at-trial move-up – no exceptions.

- Turn RIGHT onto Richfood Rd.
- Turn LEFT onto Old Richfood Rd



From I-64E East

- Take Exit 177 for I-295
- Take Exit 41B to merge onto US-301S/VA-2 S/Chamberlayne Rd
- ***Follow Directions Below

From I-64E West

- Take Exit 200 for I-295
- Take Exit 41B to merge onto US-301S/VA-2 S/Chamberlayne Rd
- ***Follow Directions Below

**** Turn LEFT at the 1st light onto Richfood Rd. At mulch piles, turn LEFT onto Old Richfood Rd. Building will be on the RIGHT.
