Wait List for Withdrawn Entries after Closing

GMKC is offering a Wait List to fill openings created by withdrawn entries after the trial's closing on March 13, 2018. A maximum of 20 entries will be placed on the wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to the trial closing date. Any entries withdrawn that are received by Sunday, March 25, 2018 @ 6pm will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial by Sunday, March 25, 2018 @ 6pm will receive a full refund.

If you have not heard about your Wait List status by Mon. Mar. 26th, contact us ASAP!

REFUNDS

Bitches in season **will not be admitted to the trial**. Any exhibitor with an entered bitch in season, on the trial date, will be refunded the entry fee, less \$3 per run (each day), upon written certification from a veterinarian. Notification must be in the hands of the trial secretary no later than 30 minutes before the start time on the date of the trial.

Injuries – Dogs that cannot compete due to an injury will be given a partial refund (in the form of vouchers for future trials) minus \$6.50 for the 1st run and \$6 for each additional run (per day). A written vet letter must be given to the Trial Secretary no later than 30 minutes before the start time on the date of the agility trial on Thursday, Mar. 29, 2018.

Please consult AKC rules and regulations pertaining to Agility Trials for complete description and eligibility for entry in these classes. The exhibitor is fully responsible for entering the dog in the correct class/division.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

ENTRY INFORMATION

- Make checks payable to "GMKC" and mail to Trial Secretary at the PO Box address ONLY. Check or money orders and **GMKC** entry certificates only – no cash!
- Overnight service **MUST** be mailed through USPS and you **MUST** check **AND** sign the "NO SIGNATURE REQUIRED" waiver box, as the Trial Secretary will not be present to sign for your entries.
- Be sure to include the correct fees. Overpayments less than \$10 will not be refunded.
- All entries must be submitted on official AKC agility entry forms, one dog per entry form. Photocopies of front & back will be accepted only if legible and official AKC size.
- Entries will not be accepted without signature, back of entry form with agreement, and fees, nor will telephone or FAX entries will be accepted.
- Owners are responsible for ensuring that entry forms are completed IN FULL. Entries submitted without ALL information will be returned as invalid.
- Returned checks do not constitute a valid entry. A \$30.00 service fee will be added for all returned checks.
- GMKC DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT

INVALID ENTRIES

Invalid entries will be returned to the address on the entry form. The following conditions constitute an invalid entry:

- An entry which is missing any AKC required information
- Entries not on Official AKC forms OR on a photocopy of an AKC form without the current agreement and rules on the reverse side or attached to the entry form
- Entries which are illegible, incomplete, or received with insufficient fees
- Conditional, unsigned, incomplete, e-mail, telephone, FAX, or telegraph entries will not be accepted.
- Returned checks do not constitute a valid entry
- A maximum of ten entries per envelope is allowed. Envelopes with more than the ten dog maximum shall be treated as an invalid entry and shall be returned to the sender.

If your dog needs to be measured, check the box at the top of the entry form so that your dog is placed on the Measuring List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

NOTICE TO EXHIBITORS

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any entry fees will be made.

Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Exhibitors are responsible for being at the ring gate when it is their turn to run. No classes will be held up by a late exhibitor.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. No dogs may be left tied to trees, cars, fences, etc.

Dogs under 4 months of age are not allowed at this trial.

RIBBONS AND AWARDS

Rosettes will be awarded to the first through fourth place dog in each jump height division in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons. MACH/PACH/AGCH Rosettes and a MACH/PACH bar will be given to exhibitors earning a MACH or PACH title at this trial. New title ribbons will be given to those earning a title. DoubleQ

ribbons will be given for those earning a qualifying score in BOTH Master level STD and JWW, regular or preferred on the same day. All ribbons and prizes must be claimed the day of the Trial. None will be mailed.

OBSTACLES

All obstacles and equipment used at this trial meet the requirements for agility trials.

MOVE UPS

Dogs may be moved to a higher class at the request of the owner as a result of qualifying for an agility title provided that the request is made in writing to the Trial Secretary and received no later than 6pm on Monday, March 26th.

Day to Day move ups must be submitted in person to the trial secretary no later than 15 minutes after the last run is judged for each class (STD, JWW and FAST).

-Or: Take I-485 East to Exit 33 (Hwy. 49N - Harrisburg). Stay on Hwy. 49 N approx 13.5 miles. Arena will be on the left.

From Albemarle: Take NC 73 West through Mt. Pleasant. Turn right on NC 49 South, travel 2.9 miles. Arena will be on the right.

From Asheboro: Take NC 49 S, go under NC 73 (bridge). Go 2.9 miles. Arena will be on the right.

From Davidson, Cornelius, Huntersville: Take NC 73 East to US 29/Hwy. 601. Turn right, travel 2.2 miles, stay left and follow US 601 to NC 49 North. At red light, turn left onto NC 49 North. Travel 3.2 miles. Arena will be on the left.

From Monroe: Take US 601 North to NC 49 North. Travel 3.2 miles and Arena will be on the left.

From Salisbury: Travel I-85 south take Exit 60. LEFT on Dale Earnhardt/Copperfield Blvd. Follow to NC 3 (approx. 1.5 miles). Turn left at the red light and follow NC 3 to US 601 (approximately go through 6 red lights). Turn left at red light onto NC 49 North and follow NC 49 3.2 miles. Arena will be on the left.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
