SET-UP - Thursday, April 25

Exhibitors may setup shade tents on Thursday afternoon after the ring fences are in place from 3 to 4 pm. If you setup before that time, you may be asked to move.

Time 2 Beat in Ring 1 followed by Premier JWW (R2); Premier STD (R1); Ex/MAS JWW (R2); Ex/MAS STD (R1); Open JWW (R2); Open STD (R1); Nov JWW (R2); Nov STD (R1)	
SUNDAY – Judging starts at 8:30 AM	1 st Walk at 8:10 am
Time 2 Beat in Ring 1 followed by Ex/MAS JWW (R2); Ex/MAS STD (R1); Open JWW (R2); Open STD (R1); Nov JWW (R2); Nov STD (R1)	
Heights will run from LOW to HIGH (4" to 24C") for all classes on all days.	
Nov/Opn FAST will have a combined briefing and walkthrough the run combined by height.	

WALKTHRU

We have 2 rings. If dogs are running in one ring, exhibitors may walk the course in the other ring if it has been approved by the judge.

Walk through groups will be clearly marked on the Gate Board.

EX/MAS STD & JWW will be split:

4" – 12" Walk -> Run

16" – 24C" Walk -> Run

CHECK-IN, MEASURING, & COURSE MAPS

We will have two VMOs at this trial – Jim and Judy Smotrel. All dogs needing to be measured must be measured PRIOR to running by a VMO. Measurements will take place when VMOs are available in the hallway outside the scoring room. Please allow sufficient time before your dog's run to be measured. We will not be using Armband labels at these trials. However, you will need to know your Armband number in order to do an At Trial move-up. Please bring a printed or an electronic copy of your trial confirmation so you will have your armband number with you.

Agility Gate will not be used due to the spotty wi-fi in the building – despite Jim's best efforts climbing on the roof! Courses will be posted and you may take photos of the courses with your phone. No paper copies will be provided. Gate boards will be by the rings – check the back of the easel for the next set of classes for check in.

MOVE-UPS

Move ups must be sent in writing (E-mail is acceptable and preferred) to the Trial Secretary for the April 25th trial no later than Monday, April 21st at 6pm. Please preface all correspondence with "DOTC-APRIL" in the Subject line.

Day to Day Move ups will be accepted but must be submitted in person to the trial secretary no later than 15 minutes after the last run is judged for each class (STD & JWW). The day-to-day move-up book will be on a chair outside the scoring room. Please do not enter the scoring room without being invited inside (sheltie alert squad inside)!

VOLUNTEERS

We are relying on our agility exhibitors to help us make our trial a success. Please be generous with your time and expertise.

Dorothy Blackwell will be the Worker Coordinator during the trial.

Workers on Friday and Sunday will receive DOTC dollars to be used for future entries at any DOTC January, April, or June/July trial.

Workers who are not exhibitors on Saturday will be included in the free BBQ lunch buffet.

All workers will receive raffle tickets.

Additional Site Info and How Things Will Work

- Indoor crating space is available in our large climate controlled building. Indoor restrooms are available. Crates and shade tents may be left overnight; however, DOTC and the Boonsboro Ruritan Club will not be responsible for any lost or damaged items left at the show site. PLEASE keep an eye on the weather – exhibitors have lost ez-ups to wind in the past – consider lowering them and removing the cover before you leave each day. Building will open at 8 am Friday and at 7 AM on Saturday and Sunday.
- 2 hoses will be available for you and your dogs at the lower field. There will not be a pool.
- Exhibitors are responsible for cleaning up after their dog(s) at the trial site and at the motels. Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.
- All RVs and campers must have a confirmation from Judy. The fee of \$10 per night will be donated to the Boonsboro Ruritan Club.
- Wi-fi has recently been installed at the Boonsboro Ruritan facility, but there is not a strong enough signal to run Agility Gate. You will be able to send and receive texts and phone calls inside the building!
- Snacks and water will be available for everyone.
- Bring your own lunch for Friday & Sunday.
- The **Saturday BBQ** will be held around noon and will be free to all exhibitors entered on Saturday. If you would like to order an additional buffet for your friends or family, the fee will be \$15 per extra ticket. Please contact Judy if you would like to order an additional ticket.
- Courses will be posted in the hallway by the bathrooms – there will not be any paper maps.
- The ring not currently running will be open for walkthrough as soon as the judge approves the course build.
- **Please do not come into the score room without permission!**

DIRECTIONS TO THE SITE

Boonsboro Ruritan Club Property

1499 Coffee Road, Lynchburg VA 24503

Note: In general, follow the signs to Rt 501 North!

US 460 - From the West of Lynchburg:

From 460, take the right-hand exit to 460 E Business (Timberlake Rd). Go about 3 miles.

At the junction of Rt 501, exit to the right and follow 501 North for about 2 miles to a traffic light at Rt 221. *Continue straight on Rt 501 N through the light at Rt 221. At the next light, turn left to stay on Rt 501 North, "NorthWest Expressway". At the next light at Boonsboro Rd, turn left (still 501 N) and go about 2 miles. Turn left onto Coffee Road (Rt 644) and go about 2 miles. The Boonsboro Ruritan Club Building is on your right.*

US 460 - From the East of Lynchburg: Exit Rt 460 at Candler's Mountain Rd (a right turn exit). Follow signs to Rt 501 North (River Ridge Mall will be on your left, and La Quinta will be on your right). Take the exit ramp to the right to Rt 501 North/Rt 29. Follow 501 N for about 3 miles to Lakeside Dr, Rt 221. See *italics* above.

US 29 - From the North of Lynchburg:

After passing the town of Amherst, stay on Route 29 South. (Do not take Business Rt. 29 South). This is the limited-access Madison Heights Bypass. After crossing the James River, Rt. 29 will join Rt. 460 West. DO NOT take Rt. 501 North Business at Campbell Ave.

Continue to Candler's Mountain Rd and follow signs for Rt. 501 North. (River Ridge Mall is on the left, and La Quinta Inn on the right). Take the exit ramp to the right to Rt. 501 North. Follow 501 N for about 3 miles to Lakeside Dr./Rt.221. See *italics* above.

US 29 - From the South of Lynchburg: Follow Rt 29 North into the city limits (pass River Ridge mall entrance on your right). Take the exit ramp to the right to Rt 501 North and proceed for about 3 miles to Rt 221. See *italics* above.

This is a preliminary judging schedule which is contingent upon the move-up of entries that may not have been received yet.
